The most hotly debated issue was our "isularity"; no recognition of what was happening on the Continent, to which we would in time have to become aligned. He had ducked the 2 tier alternative & produced a fudge. ^(Philip Clappole) Fred

Meubauer, part author of an authoritative work on Comparative Board Behaviour, came in

at this point and described how boards tend to perform in much the same way regardless

of structure. He believes there will be convergence and that we will move to the 2 tier system.

On the same grounds, audit committees were attacked.

Was it reasonable to expect m.e.d's to do all we were expecting of them?

More ones should be put on auditors (why don't they ever resign?).

Is self-regulation preferable to statute?

All m.e.d's should be independent.

One questioner was highly critical of the ~~ATI~~ effort in Brussels - under-resourced.

Meanwhile Community legislation was going ahead - responsibilities of directors, Company

Law Commission, enforcement proposals - and our viewpoint was not being represented.

We needed to adopt more of a Community perspective. He also stressed the vital

importance of information for m.e.d's, & of the info. system as a whole.
